HOW TO APPLY ?

Pre-requisites for applying online

Prospectus

Download and read the prospectus of KEAM 2017 before applying for KEAM. The applicant should read carefully the instructions and be aware of various Clauses of KEAM prospectus.

Images to be ready for upload

- Jpeg format of candidate's recent Photograph
- Jpeg format of candidate's Signature
- Jpeg format of candidate's Left hand Thumb Impression.

See the '<u>Guidelines for Upload Images'</u> for detailed instructions and specifications.

Email ID and Mobile Number

Candidate should possess a valid email id. Keep this email id live and secure till the end of the admission process of KEAM 2017. If the candidate does not have an email id, a new email id must be created before applying online. Candidate should not provide the email id of others, under any circumstances. Candidates should provide their own mobile number or parent's mobile number at the time of online application. All important communication regarding the KEAM will be sent to the registered Mobile Number.

Certificates

The following certificates will be useful to fill the name, date of birth, address of the candidate and income and communal reservation details.

(a) Birth Certificate / SSLC / Passport

This will help for entering Name, Date of Birth and address of the candidate accurately. If the place of birth is mentioned in the above certificate, the copy of same may be attached as a proof of nativity and date of birth, along with the printout of application.

(b) Income Certificate

Income certificate from the concerned Village Officer may be obtained, if needed, before filling up the application which helps to fill up the income details in the online application. The income provided will be considered for any fee concession/scholarship/other benefit that may be announced later. Original copy should be submitted along with the printout of application.

(c) Non-Creamy Layer Certificate/Community Certificate, if any for Category claim

If you have any claim for communal reservation, obtain a Non-Creamy Layer Certificate for SEBC/OEC claim or a Community Certificate for SC/ST reservation from the Village Officer/Tahasildar, concerned. The name of caste should be entered as in the certificate. Original copy should be submitted along with the printout of application.

(d) Certificate for Special Reservation, if any

If you claim any special reservation, original certificate is required to be submitted along with the printout of application. So prior to filling up the relevant column in special reservation category, candidate should procure the certificate.

Computer System

The computer system used for applying online should have the following facilities:

Internet : Should have an internet connection.

Browser : Should have a browser. Recommended browsers are Mozilla Firefox and Google Chrome.

PDF Reader : Should have a PDF reader like, Adobe PDF reader or Foxit Reader.

Printer : The printout of application should be taken in Laser printer/Deskjet Printer in A4 size white paper.

Application Fee

Candidate should pay the application fee in any one of the following mode:

- <u>Online Payment</u> using Debit Card / Credit Card / Internet banking.
- Payment at all Head and Sub *Post Offices* in Kerala state by using <u>e-Challan</u> generated during online submission of application.
- Payment at any of the selected State Bank of Travancore (SBT) branches by using e-Challan.

How to Register 1. Name of Applicant :

Note:- Name, DOB, Email ID and Mobile number cannot be changed later.

1. Name of Applicant :

Give Name of Applicant as in the SSLC or other relevant certificate. But the name should not be started with the initial. (Correct examples are DEVIKA K S or ATHUL G NAIR) Do not put a dot(.) between initials and name. Instead, provide a blank space. Remember, the name cannot be edited in later steps.

2. Date of Birth :

Select Day, Month and Year of birth as in Xth certificate/birth certificate. Age proof must be attached along with printout of the application. Applicants should have completed 17 years of age as on the 31st December of this year. There is no upper age limit.

3. Email ID :

Provide your personal valid Email ID. Keep this email id live and secure till the end of the admission process of KEAM. If you do not have an email id, a new email id may be created before applying online. <u>Candidate should NOT provide the Email ID of others</u>, such as internet cafe, Akshaya centres, etc. under any circumstances. If the candidates forget their password or key

If the applicant is sure that the information provided are correct, press <u>'Confirm'</u> button.

Step 1 : Upload Images

Guidelines for Upload Images

The first step for filling up application is to upload scanned images of photograph, signature and left hand thumb impression of candidate.

Photograph of Candidate:

For applying online, the candidate must have a scanned/digital image of photograph. The Specification of photograph image should be as follows (to be strictly followed):

- Photograph must be in colour with a light colour background, white is preferable.
 It must be taken in a professional studio. Photo taken by mobile phone/tab is not accepted.
- Photograph should be in passport size format. Front view of full face and shoulder portion of candidate is to be seen clearly in the photograph.
- The face of the candidate should be straight and at the centre.
- Photo, wearing caps and dark glasses will be rejected.
- Scanned image file should be in **jpg format** (Jpeg).
- Dimensions of the photograph should be 150 pixels width and 200 pixels height.
- Image file should be **between 10 kb and 30 kb** file size.
- Candidate's name and date of photo taken should be printed at the bottom portion of the photograph with black letter and white background.

Very Important :

- 1. If the face in the photograph is not clear or the image is not as per the above guideline, your application is liable to be rejected.
- 2. A printed copy of the uploaded photo should be affixed on the specified place in the printout of the application and get it duly attested by a gazetted officer/head of institution where the candidate has last studied.
- 3. The uploaded photo and photo affixed on the printout of application should be identical. Otherwise application is likely to be rejected.

In future, your Admit Card, Data Sheet and Allotment Memo will be printed with the same photograph you have submitted at this stage. Moreover, in examination hall, the Invigilator has to verify the same photograph for identifying the candidate. So strictly follow the specifications and guidelines for the photo to be uploaded.

Signature of Candidate

- On a plain white sheet, the candidate should put his/her signature with black/blue ink. Signature should be clear.
- Scan this signature and crop around the signature.
 Do not scan the full sheet. Scanned image file should be in jpg format. (Jpeg)
- Dimensions of the image of signature must be **150 pixels width** and **100 pixels height**.
- Image file should be between **10 kb** and **30 kb** file size.



- If the face in the photograph is not clear, your application is liable to be rejected.
- Keep a printed copy of uploaded photograph in your custody for affixing in the printout of application.
- The uploaded photo and photo affixed on the printout of application should be identical. Otherwise application is likely to be rejected

Left Thumb impression of Candidate

- Place left hand thumb on an ink pad. Put thumb impression on a white paper.
- Scan this paper and get the image of thumb impression cropped.
- Image file should be in jpg format. (Jpeg)
- Dimensions of the image of signature must be **150 pixels width** and **100 pixels height**.
- Image file should be between **10 kb** and **30 kb** file size.

Note that the file size and dimension of signature and thumb impression are same.

Subsequent to selecting the three images, candidate needs to verify whether the photograph shown in the screen is candidate's own, clear and sufficient to identify the candidate. If so, check the declaration stated against the row of photograph. Similarly, verify the genuiness and clarity of signature and thumb impression, then **Accept the Declarations** indicated against each. Press **'Upload Images'** button to upload all images to the application portal.

If you try to upload an image which is not in the prescribed format, an error messages will be displayed in 'Upload Images' column. All images should match the corresponding specification.

The images once uploaded cannot be changed after completing step 3 of 'Fill Application'.

12. Community Claimed for Eligible Reservation :

Candidates who need any communal reservation can claim it through this section. Those candidates who come under SEBCs or Other Eligible Community(OE) should submit Non Creamy Layer Certificate in the prescribed format along with the Printout of Application.

But the status EC (Eligible for Educational Concession as is given to OEC) will be allowed only after verifying the Income Certificate with annual income not more than Rs. 6,000,00/-)

The certificate produced for getting communal reservation should be an Original certificate and it must be attached along with the Printout of Application.

Candidates who claim SC/ST reservation should produce Community Certificate from Tahsildar along with the Printout of Application. For claiming Jewish category, Community Certificate from Village Officer/Tahsildar is to be submitted with the application. Based on the community selected, the Category claimed will be displayed against the head "**Category Claimed by the Candidate**". But the Category claim will be allowed only after the verification of original Non Creamy Layer / Community Certificate as the case may be.

If the candidate is not eligible for any communal reservation or not able to produce a valid certificate, select **'General'** as the community.

(i) Provide 9 digit Certificate Number, if the certificate is in digitally signed (edistrict) format:

If you have obtained the income certificate in edistrict format, type the 9 digit Certificate Number here. This number can be seen at the top left of Income certificate, under the QR Code.

(ii) Provide 5 digit Security Code, if the certificate is in digitally signed (edistrict) format:

It is also applicable only for Community certificate in edistrict format only. This number was printed at the bottom portion of the certificate.

These two fields are optional. But the two numbers help the CEE to verify the authenticity of the document very easily and the candidate will get the benefit of claiming the reservation at the earliest.

Candidates who are children of Inter-Caste married couple of whom one (father/mother) is SC/ST, will be eligible for educational and monetary benefits admissible to SC/ST as per Para 2 (ii) of GO (MS) No.25/2005/SCSTDD dated 20.06.2005. e-Challan :

When the mode of payment is e-Challan, the applicant needs to take a printout of e-Challan by using the link <u>'Print e-Challan</u>'. Payment can be made in cash at

- Selected branches of State Bank of Travancore (SBT) in India or
- <u>All Head and Sub</u> Post Offices in Kerala state.

Print the e-Challan and it should be handed over to the bank/post office along with the cash.

The bank/post office official will make necessary entries both in their online portal and e-Challan form.

The e-Challan must be collected back from the bank/post office official. It must be ensured that the official has recorded the Transaction ID pertaining to the payment on the candidate's copy of the e-Challan and put the office stamp and his/her initials at the designated places on the counterfoil. An amount of Rs. 25/- has to be paid as service charge in addition to the Application Fee.

If the payment was successful, the '**Payment Application Fee'** (step-4) tab in the candidate's home page turns **green**.

Logout from the Application Portal

If candidate wishes to leave the computer system or he/she has completed the online submission of application, he/she must quit from the application portal by clicking the 'Logout' link. This action is compulsory for preventing the misuse of his/her Home Page by strangers.

Available status on the home page is given below.

Registration	:	Indicates Candidate's Registration for online application.
Upload Images	:	Shows whether the images of photograph, signature and thumb impression are uploaded in the portal.
Fill Application	:	Indicates the application is filled up and finally submitted.
Pay Application Fee	:	Shows whether the payment confirmation reached the CEE office.
Print Application	:	Denotes the printout of application is taken or not by the candidate.
Received by CEE	:	This status shows whether the application sent by the candidate has reached the CEE office and taken for scrutinizing or not. Remember, it may take several days to update this status. This status will be turned to green only when the application is taken for scrutiny.

The **Green** color on the status indicates the completion of the respective step. The **Red** represents that the respective step has not been performed so far. Safety Tips for online application submission

• Secure your Password

Never share, disclose, or provide your password to others. Never save this information in publicly accessed computers. CEE will never send you an email or other communication requesting the password.

• Use your own email-ID and Mobile number

Never provide email-ID of others. Furnish the mobile number of candidate or parents. Future communication, new password, etc may be sent to the registered email and mobile number.

Use recommended Browsers

Always use the latest version of Mozilla Firefox and Google Chrome.

• Clear your Browser's cache and cookies

If you use public or shared computer to access the application portal, it is better to clear the browser's cache before you sign in to online application. Shift+Ctrl+Delete key help to clear the browsing history and cached memory.

• Do not use Multiple Window/Tab in the browser

Do not open more than one KEAM application portal across multiple windows or tabs in the same browser.

• Frequently use 'Save' button available in the application portal

Four numbers of 'Save' buttons are available in the Fill-up application section of the application portal (Seen on the right part of portal). While filling up of application, use any one of 'Save' button frequently, to save the entered data. This will prevent the loss of entered data due to any unexpected shutdown or quit. - If Applicant's *signature and thumb impression are not clear* and not genuine.
- If proof for *Nativity is not attached* along with the printout of the application.
- If the required Application Fee meant for each category (General or SC) is not paid.
- If the printout of *application* (use the 'Print Application' link) and supported documents *reach after the last date specified*.

So, utmost care should be taken while applying for KEAM and sending the duly filled application with the supporting proof to the office of the CEE within the stipulated time.
