Individuals/institutions who have made extraordinary contributions in the field of science and technology communication over the last five years will be considered for these awards. These awards will be announced on the National Science Day 2010.

DETAILS INCLUDING ELIGIBILITY CRITERIA:

- a. This scheme is open to resident Indian citizens/institutions registered in India. Individuals who are employed in the Departments of Science and Technology, Scientific and Industrial Research and Biotechnology are not eligible for these awards.
- b. For these awards outstanding work, efforts and achievements of the past five calendar years (2004 onwards) will be considered.
- c. If more than one individual/institution is selected for an award, the amount of that award may be shared equally among them.
- d. Direct applications or self-nominations will not be considered. Nominations will be accepted only in the specified format

PERSONS ELIGIBLE TO NOMINATE: Heads of national science academies, Presidents of professional science & engineering societies, Vice Chancellors and Registrars of Universities, Directors of research laboratories, Heads of Departments in central and state governments, Heads of organisations, Chairmen of registered societies of S&T based voluntary organizations and science communicators who have been honoured with these awards in previous years.

GENERAL TERMS AND CONDITIONS:

- 1. (i) Entries received on earlier occasions for these awards will not be admissible without fresh accomplishment(s) relevant to the award.
 - (ii) RVPSP/DST will have the sole right to select the awardees and formulate rules governing such selection.
 - (iii) Canvassing in any form will be a disqualification.
 - (iv) No correspondence will be entertained regarding the selection of the awardees or the selection procedure.
- 2. (i) A selection committee consisting of eminent persons will recommend names for the awards.
 - (ii) The decision shall be final and binding in all respects.
 - (iii) The committee may, if it deems fit, decide to recommend, the name of an individual or an institution for an award, even if he/she/it has not been nominated for the same.

- (iv) The committee invited shortlisted nominees to present their accomplishments to assist in the selection in thet past. Similar methods may be adopted this time.
- 3. Awardees shall be intimated by post and through selected newspaper announcements.
- 4. Each award winner will be expected to deliver an oration and three popular lectures within the next twelve months at a place and venue to be intimated.
- 5. All materials/scripts/toys/kits (only one set) may be submitted for consideration of the nomination these are non-returnable.
