1.	That I am the owner/Licensee/Manager of the above Pool and am fully competent to swear and execute this Affdiavit.(documents attached).		
2.	That the location and functioning of the said Swimming Pool is free from all legal encumbrances and also does not in any manner violate the conditions of MPD-2021.(documents attached).		
3.	That the sufficient number of life guards, buoys will always be present at the premises to avoid any untoward incident during the current year of operation. No person below the age of 14-years will be employed by the management.		
4.	To keep ready at hand at least two buoys whenever the pool is being used by a beginner.		
5.	To provide separate bath rooms and dressing rooms for the males and females.		
6.	That no incident of eve-teasing has taken place in the past and I vouch to prevent the same in future.		
7.	That no undesirable elements will be allowed in the vicinity of the pool during operational hours.		
8.	To not allow more than the number of persons specified in the license to use or be in the pool at any one time.		

9. That the pool will not be used for any purpose other than as specified in the License.

- 10. To employ an instructor who has adequate knowledge of first aid and artificial respiration and shall ensure that such person is present at the swimming pool during the period it is kept open to the public.
- 11. To keep and maintain on the premises of the pool a first aid box containing the necessary material.
- 12. To keep the water in the pool clean and change it at least once a month and also at shorter intervals as per the directions of Licensing Branch.
- 13. To submit the Water Test Report before 7th of each month during the current year of operation of the pool.
- 14. I also undertake not allow any person for the following:-
 - (a) to enter the waters of the swimming pool unless he has taken a shower bath and a foot bath in the bath room provided by the licensee on the premises of the pool.
 - (b) To enter or remain in the pool at any time other than that prescribed under these regulations or to enter or remain on the premises appurtenant to the swimming pool fifteen minutes before or after the opening and closing hours, respectively.
 - (c) To enter the waters of the swimming pool in any apparel other than either a recognized swimming costume or a swimming trunk.
 - (d) Either before or after entering the waters of the pool to use soap oil or any other substance or preparation whereby the waters of the pool may be rendered turbid or unfit for use of bathers.
 - (e) Willfully or otherwise to foul or pollute the waters of the pool by spitting or in any other manner whatsoever.
 - (f) Suffering from any skin disease, venerable disease or any other contagious disease to use the swimming pool.
 - (g) Who does not know swimming or is beginner to enter the waters in the absence of a qualified instructor appointed under these regulations.
 - (h) Below the age of eight years to enter the waters of swimming pool unless he is accompanied by an adult person.
 - (i) The licensee shall not allow any animals to enter the swimming pool or the premises appurtenant thereto.
