2. (a) The Licensee shall carry on the aforesaid business at the following places:-

(b) Essential commodities shall not be stored at any place other than of the godown/s mentioned below:

Note: - (1) The address of the godowns/s within the jurisdiction of the licensing authority should only be mentioned.

(2) If the licensee intends to store the essential commodities in godown/s other than those specified above, the licensee shall give prior intimation of the actual occupation of any such godown/s within forty eight hours of the actual occupation thereof and shall produce the license for making requisite changes there in by the licensing authority.

(3) The licensee shall submit in the form appended, to the licensing authority concerned and the Director of Food and Civil Supplies (Civil Supplies Wing) a true return in the prescribed in form "C" showing the stocks, receipts and deliveries of scheduled commodities every fortnight (15th and the last day of every month). The return should be submitted so as to reach the concerned within 4 days of the stipulated date.

(4) The licensee shall give all facilities at all reasonable times during the usual working hours of his business concern to the licensing authority any other officer authorised by him for inspection of his stocks and accounts.

(5) The licensee shall not contravene any of the provisions of the Karnataka Essential Commodities Licensing Order, 1986 or any other order relating to Essential Commodities issued under the Essential. Commodities Act, 1955 (10 of 1955) either by the State or Central Government.

(6) The licensee shall not:-

(a) Have in his possession or under his control stock in excess or short of the net quantity of scheduled commodities revealed by his accounts.

(b) Keep the stocks of schedule commodities in his premises or godowns when once they are sold by him.

(c) Have in his possession or under his control or shall sell food articles which do not conform to the specification of prevention of Food Adulteration Act 1954 and the rules made there under from time to time”

(7) The licensee shall comply with any direction that may be given to him by State Government or the Director of Food and Civil Supplies or the Licensing Authority in regards to purchase, sale and storage for sale of any essential commodities and in regards to the language in which the register, returns, receipts or invoices mentioned above shall be written and the authentication and maintenance of the registers etc.

(8) The licensee shall take adequate measures to ensure that stocks of essential commodities stored by him are maintained in proper conditions and that damage to them due to ground moisture, rain, insects, rodents, birds, fire and such other causes is avoided. Suitable dunnage shall be used to avoid damage from ground moisture and stocks of essential commodities thus stored shall be fumigated with chemicals approved for the purpose by persons who have undergone practical training in that behalf. The licensee shall also ensure that fertilisers, insecticides and poisonous chemicals are not stored along with such stocks of essential commodities in the same godown or in immediate juxtaposition of the said stocks of essential commodities.
