1. Subject to the provisions of the Karnataka Essential Commodities Licensing order, 1986 and to the terms and conditions of the License Shri/M/sis/are hereby authorised to purchase sale and storage for sale of the following scheduled commodities.
(1) Food grains
(2) Sugar.
(3) Kerosene.
(4) pulses.
(5) Edible oil.
(6) Edible oil seeds.
(7) Gur.
2. (a) The licensee shall carry on the aforesaid business at the place mentioned below :-
2. (b) Essential Commodities shall not be stored at any place other than any of the godown/s mentioned below:-

## Note:-

- (1) The address of the godown/s within the jurisdiction of the Licensing Authority should only be mentioned.
- (2) If the licensee intends to store the commodities in godown/s other than those specified above, the licensee shall give intimation of the actual occupation thereof and shall produce the license for making changes therein to the licensing authority.
- (3) In the case of the Hawkers the Licensing Authority may specify the place or places in which or hours during which the licensee shall carry on business.
- (4) The licensee shall submit in the prescribed form "E" to the licensing Authority concerned, a true return showing the stock, receipts and deliveries of a scheduled commodities every fortnight (15<sup>th</sup> and the last day of the month). The fortnightly returns should be submitted, so as to reach the concerned authority within 4 days of the stipulated date.
- (5) The licensee shall give all facilities at all reasonable times during the usual working hours of his business concern to the Licensing Authority or any other officer authorised by him for inspection of his stocks and accounts.
- (6) The licensee shall use the weights and measures duly approved by the weights and Measures Department only while supplying essential Commodities to the consumers.
- (7) The licensee shall not contravene the provisions of the Karnataka Essential Commodities Licensing order, 1986 or any other order relating to essential commodities issued under the Essential commodities Act, 1955 (10 of 1955) either by the State or Central Government.
- (8) The licensing shall not have in his possession or under his control any essential Commodities in excess or short of the net quantity revealed by his accounts.
- "(8 A) have in possession or under his control or shall sell food articles which do not conform to the specifications of the prevention of Food Adulteration Act 1954 and rules made there under from time to time".
- (9) The licensee shall comply with any direction that may be given to him by the State Government or the Director of Food and Civil Supplies, or Licensing Authority in regard to purchase sale and storage of sale of any essential commodities and the hours of sale are any other matter relating to essential commodities which the State Government or Licensing Authority may think fit to regulate.
- (10) The Licensee shall take adequate measures to ensure that stocks of essential Commodities stored by him are maintained in proper condition and that damage to them due to ground moisture, rain, insects, rodents, birds, fire and such other causes is avoided, suitable dunnage shall be used to avoid damage from ground moisture and stock of essential commodities the stored shall be fumigated with chemicals approved for the purpose by persons who have under gone practical training in that behalf the licensee shall also ensure that fertilisers, insecticides and poisonous chemicals are not stored along with such stocks of essential commodities in the same godown or in immediate juxtaposition of the said stocks of essential commodities.
  - (11) In addition to the above conditions, the following conditions shall be fulfilled by the Hawkers.
    - (a) A passport size photo of the licensee (Hawker) shall be affixed in the marginally noted space attesting his signature by the Licensing Authority.
    - (b) The Licensee shall maintain a "Hand Book" showing his name, Address, Licensee No. in the first page of the book and thereafter write the details of transaction in kerosene done on each day showing the date, opening stock; on each day, purchases made during the day, total sale made during the day and closing balance and shall produce this Hand Book for verification when demanded by the Licensing Authority or any Officer authorised in his behalf.
