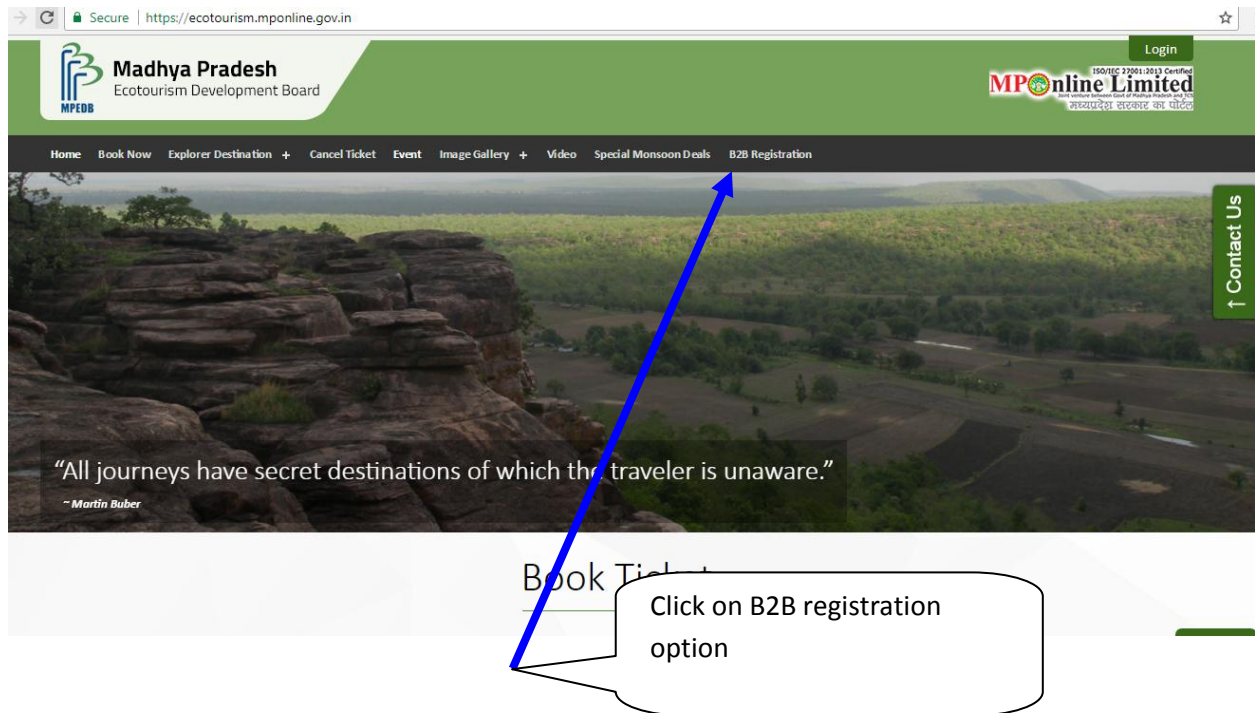
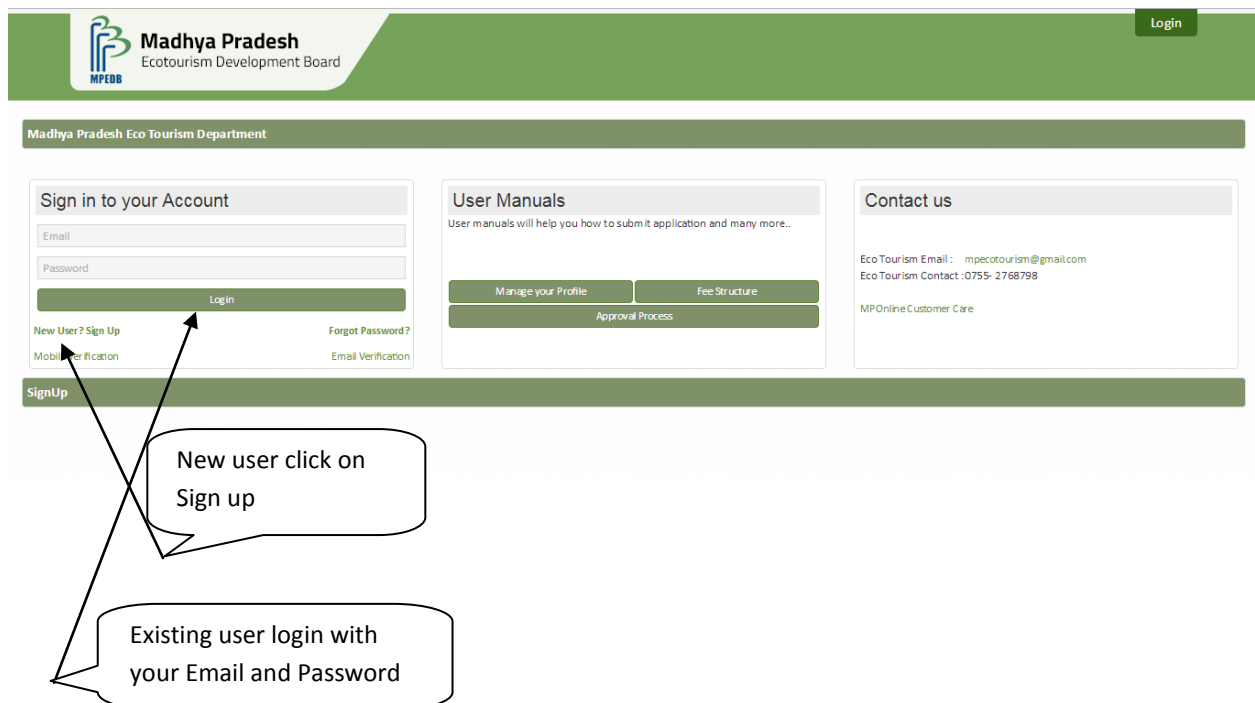


## Process of Doing Registration under B2B Module
