- f) Thumb impression, if used, should be attested by Notary Public or an authorized officer in respective country of residence under official seal and stamp.
- g) AO code (Area Code, AO Type, Range Code and AO Number) of the Jurisdictional Assessing Officer must be filled up by the applicant. These details can be obtained from the Income Tax Office Or IT PAN Service Centers (managed by UTIITSL) Or UTIITSL website www.utiitsl.com
- h) At the time of applying for PAN, the applicant has to submit Proof of Identity (POI), Proof of Address (POA), documents.

14. Name and address of Representative Assessee
